



**White Bear Lake Area Schools
School Board Meeting Highlights
November 14, 2016
Regular Meeting**

Before the November 14, 2016 Regular Board Meeting of the White Bear Lake Area School Board, the School Board recognized students who competed at the state level - girls' and boys' cross country team members and middle school and high school cheer team members.

At the November 14, 2016 School Board Meeting of the White Bear Lake Area School Board, the following agenda items were presented and discussed:
